Evergreen conducted a public information meeting in Lincoln on August 20, 2008, and another in Lee on September 17, 2008. In addition, Evergreen has held meetings regarding the Rollins Wind Project with the Lincoln Town Council, the Egg Pond Association, the Madagascal Pond Association, and the Mattawamkeag Wilderness Park. Evergreen also met with two local ATV clubs, the Penobscot Off Road Riders and the Dwinal Pond ATV Club.

Finally, a public information meeting in accordance with DEP rules (06-096 CMR Chapter 2) was held In Lincoln on October 15, 2008. See Appendix 25-1 for the notice of filing and certificate of notice, and Appendix 25-2 for the abutters list.

Appendix 25-1

PUBLIC NOTICE FILING AND CERTIFICATION

The DEP Rules, Chapter 2, require an applicant to provide public notice for all Site Location projects with the exception of minor revisions and condition compliance applications. In the notice, the applicant must describe the proposed activity and where it is located. "Abutter" for the purposes of the notice provision means any person who owns property that is BOTH (1) adjoining and (2) within one mile of the delineated project boundary, including owners of property directly across a public or private right of way.

1. **Newspaper:** You must publish the Notice of Intent to File in a newspaper circulated in the area where the activity is located. The notice must appear in the newspaper within 30 days prior to the filing of the application with the Department. You may use the attached Notice of Intent to File form, or one containing identical information, for newspaper publication and certified mailing.
2. **Abutting Property Owners:** You must send a copy of the Notice of Intent to File by certified mail to the owners of the property abutting the activity. Their names and addresses can be obtained from the town tax maps or local officials. They must receive notice within 30 days prior to the filing of the application with the Department.
3. **Municipal Office:** You must send a copy of the Notice of Intent to File and a **duplicate of the entire application** to the Municipal Office.

ATTACH a list of the names and addresses of the owners of abutting property.


CERTIFICATION

By signing below, the applicant or authorized agent certifies that:

1. A Notice of Intent to File was published in a newspaper circulated in the area where the project site is located within 30 days prior to filing the application;
2. A certified mailing of the Notice of Intent to File was sent to all abutters within 30 days of the filing of the application;
3. A certified mailing of the Notice of Intent to File, and a duplicate copy of the application was sent to the town office of the municipality in which the project is located; and
4. Provided notice of, if required, and held a public informational meeting in accordance with Chapter 2, Rules Concerning the Processing of Applications, Section 14, prior to filing the application. Notice of the meeting was sent by certified mail to abutters and to the town office of the municipality in which the project is located at least ten days prior to the meeting. Notice of the meeting was also published once in a newspaper circulated in the area where the project site is located at least seven days prior to the meeting.

The Public Informational Meeting was held on October 15, 2008.

Approximately 35 members of the public attended the Public Informational Meeting.

NOTICE OF PUBLIC INFORMATION MEETING AND INTENT TO FILE

Please take notice that Evergreen Wind Power III, LLC ("Evergreen III"), a subsidiary of First Wind, with its principal offices at 85 Wells Avenue, Suite 305, Newton, MA 02459, (617) 964-3340 intends to file a Natural Resources Protection Act permit application and a Site Location of Development permit application, pursuant to the provisions of 38 M.R.S.A. §§ 480-A et seq. and 38 M.R.S.A. 38 M.R.S.A. §§ 481-490, respectively, and regulations thereunder. Evergreen III will also be seeking a Section 401 Water Quality Certification pursuant to 33 U.S.C. § 1341. The applications will be filed on or about October 24, 2008.

In connection with that application, Evergreen III will hold a public information meeting at Mattanawcook Academy, 33 Reed Drive, Lincoln, Maine on Wednesday, October 15, 2008 from 6:00 p.m. to 8:30 p.m. The purpose of the meeting is for Evergreen III to seek public comment on the proposed Rollins Wind Project.

The application is to allow for construction and operation of the Rollins Wind Project. The Project includes 40 wind turbines in the towns of Burlington, Lee, Lincoln and Winn; an electrical connection line linking the turbines; approximately 8.8 miles of new electrical transmission line in the towns of Winn and Mattawamkeag; an electrical substation in Lee; and an operations and maintenance building in Lincoln.

A request for a public hearing must be received by the Maine Department of Environmental Protection (Department), in writing, no later than 20 days after the application is found by the Department to be complete and is accepted for processing. A public hearing may or may not be held at the discretion of the Commissioner. Public comment on the application will be accepted throughout the processing of the application.

The application and supporting documentation will be available for review at the Department's office in Augusta during normal working hours. Additionally, the application and supporting documentation will be available for review at the following municipal offices: Lincoln, Lee, Winn, Burlington and Mattawamkeag.
